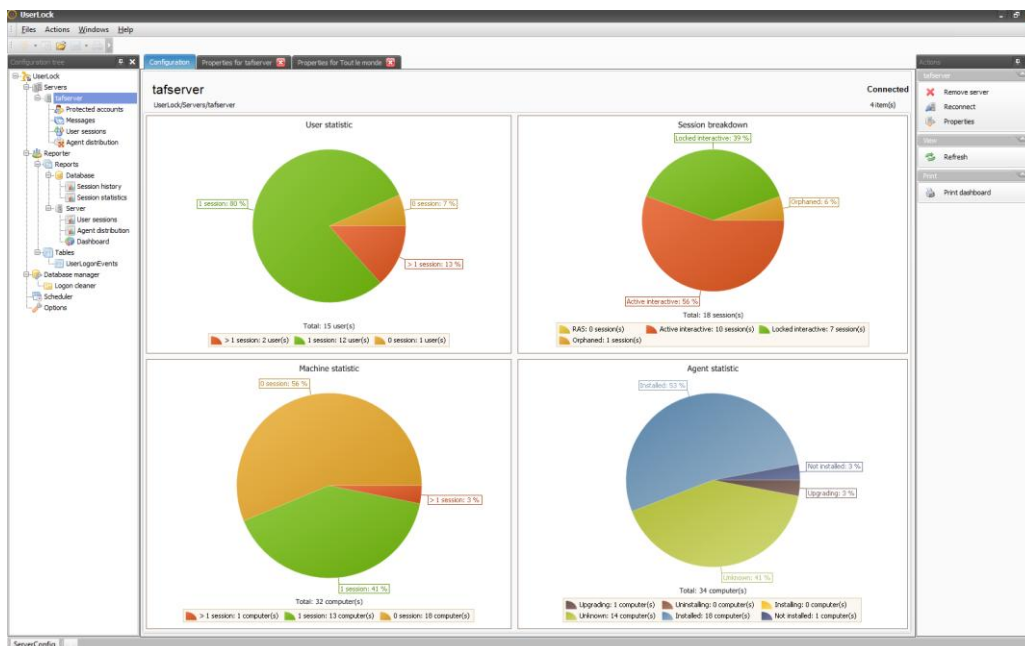

- to define working hours and/or maximum session time for protected users and disconnect users with prior warning outside of the defined timeframe(s) and/or when time is up
- user group's network access restriction per workstation or IP range
- to notify all users prior to gaining access to a system with a tailor-made warning message (legal disclaimer, etc.)
